CALL FOR QUOTATIONS: RENOVATION OF ASSEMBLY STAGE

1. This school needs to renovate Assembly Stage in sports ground at Army Public School, Primary Wing, Meerut Cantt. The following works are required to be carried out for renovation of assembly stage. You are requested to send your quotation in a sealed envelope to reach this school by 24 Nov 2024:-

2. GST No should be mentioned on quotations. Rates quoted must be inclusive of all taxes, levies and other charges. Vendors are requested to visit the school to see the site before quoting the rates.

3. The following terms and conditions will be applicable:-

(a) **Quality.** The quality of the material will be as per ISI approved standards.

(b) **Liquidated Damages.** The vendor understands that time is of essence in providing the services under this contract. If the vendor shall fail to complete the work within the time for completion prescribed in the work order/contract, or any extended time for completion in accordance with the contract, then the vendor shall pay to Army Public School, Meerut Cantt 0.5 % of the value of the delayed period per week upto maximum 10% of the project cost, as liquidated damages. The said sum shall be payable by the sole fact of the delay without the need for any previous notice or any legal proceedings, or proof of damage, which shall in all cases be considered as ascertained.

(d) **Completion Period**. Work shall be completed within **45 days** from the date of work order at Army Public School, Meerut Cantt. Please note that work order can be cancelled unilaterally by the Buyer in case work is not completed within the stipulated period. Extension of completion period will be at the sole discretion of the buyer, with applicability of LD clause.


4. **Warranty**. Vendors will provide minimum **One Year (12 months)** free onsite comprehensive warranty. During warranty, the vendor will replace without any cost any portion/complete area becomes damage.

5. **Payment Terms**. Payments will be made one time through cheque/NEFT in the name of Firm, after supply/successful completion of work and checking by the Board of Teachers and certifying that the quality of material used is of standard quality, as per specification/ description and work is satisfactory. No advance payment will be made.

6. **Earnest Money Deposit**. Quotation must be accompanied with a Demand Draft (No Cheque/Cash) of Rs 15,000/- (Rupees Fifteen Thousand only) in favour of the Army Public School Meerut Cantt which is refundable on non acceptance of quotation.

7. **ESIC**. As per order ESIC @ 4% on labour charges will be deducted at the time of payment. The bill will clearly show the labour component for calculation of the ESIC. You are requested to share your ESIC Code issued by ESIC office if you possess of the same

8. **Inspection Authority**. The inspection will be carried out by a Board of Teachers on behalf of the buyer. The mode of inspection will be joint inspection.
